This guide is designed to help you with the MobileTM demo on your cell phone. We have tested this demo on every type of phone including a cell phone that is not a PDA. Follow the steps below to start your demo.

Type the following link in your cell phone browser address bar.

www.halakdemo.com

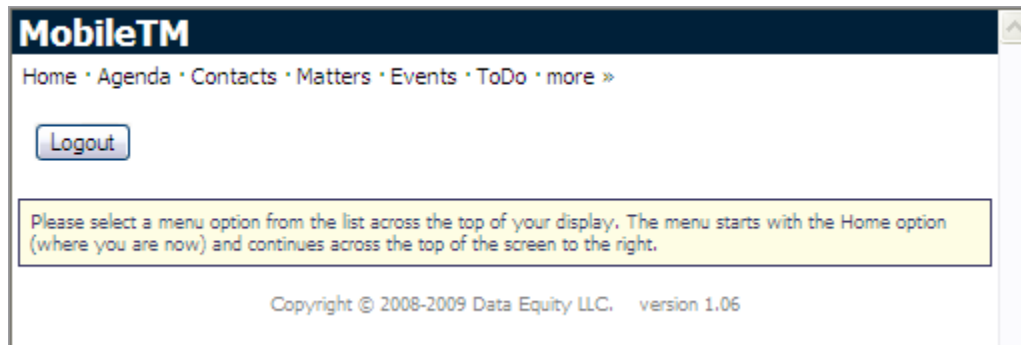

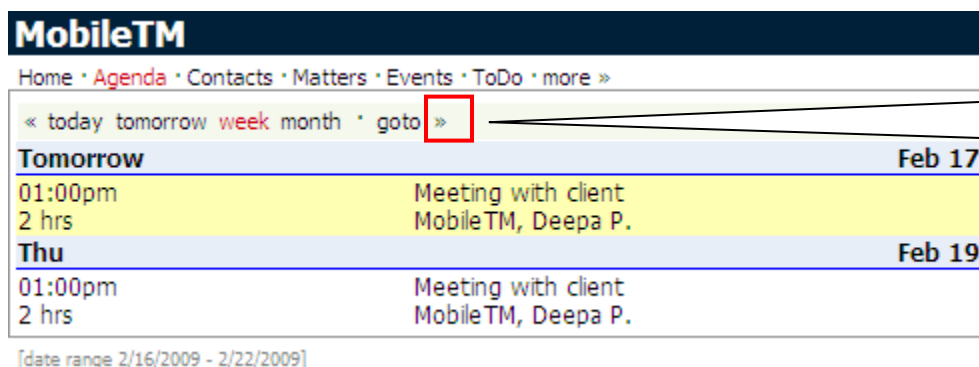
